VISION AND APPROACH

In the wake of the economic crisis and in a country where politics has all too often been beset by scandals and corruption, Vouliwatch aims to help develop an open and accountable political system that uses new digital technology to promote citizen participation in the political process and to rebuild trust in parliamentary democracy.

In the heyday of Ancient Greek democracy, citizens actively participated in political dialogue, and Vouliwatch aims to revive this essential aspect of a democratic society through the use of digital technology.

Vouliwatch is a digital platform that offers Greek citizens the opportunity to publicly question MPs and MEPs on the topic of their choice, and to hold their elected representatives accountable for their parliamentary activity.

Moreover it acts as a parliamentary "watchdog" by providing first hand reporting on the latest legislative developments in parliament as well as by monitoring the voting behaviour of elected representatives.

It also gives users the chance to influence political debate and to focus the attention of both the media and the politicians on issues that citizens believe are important and are not being discussed widely.

Vouliwatch's scope expands beyond the digital realm as it is a strong campaigner and advocate for parliamentary opennes, public access to data and political transparency.





MESSAGE FROM THE BOARD

When writing last year the equivalent message for our first annual report, no one suspected that 2015 would be yet another year filled with unprecedented tensions and twists for our generation.

Today we are under the strong impression that a new world is coming to life amidst distress, insecurity and abrupt changes. Like most people around us, Vouliwatch is too facing a daily battle with reality: to record, to listen, to analyse and to give a voice to those that aren't heard and are caught in the quick sand.

The consecutive electoral battles and the intense parliamentary life provided us with the opportunity to upgrade our applications, produce more news and to introduce and engage even more Members of Parliament and citizens with our platform.

Last November we participated for the first time in the global summit of the Open Government Partnership in Mexico as our Vouliwatch is the sole organisation promoting parliamentary transparency in Greece.

2015 was a year that showed us that the potential for the further development of our endeavour is indeed great. For this reason our strategy focuses on three main axis: education – participation – accountability.





In 2016 Vouliwatch will continue to bring citizens and Members of Parliament closer by upgrading its platform and digital tools.

We will give emphasis to the familiarization of the younger generation with parliamentary democracy through educational programs and relevant actions. Through international as well as national initiatives we will assert our role in the shaping of policies for good law-making, digital and open governance whilst supporting openness at local and regional level too.

Only informed citizens can assert better policies, control and judge legislative and executive authorities and open up exclusive and corrupt systems.

There is no going back in Vouliwatch's development and growth, with your participation and support we can only become stronger, more influential and assertive.



ABOUT VOULIWATCH

Vouliwatch was officially registered as a non for profit organisation in October of 2013. The organisation formally started its activities with the launch of its digital platform on the 16th of March 2014.

Vouliwatch is a digital platform that engages Greek citizens with legislative politics and grants them with the opportunity to communicate, evaluate and hold elected representatives in the Greek and the European Parliament (MPs & MEPs) accountable.

Similar successful initiatives ("Parliamentwatch") in countries like Ireland, Luxemburg, Tunisia, Germany, France and Austria have been sources of inspiration for our team as well.

Vouliwatch is an independent, non-profit initiative aiming to promote public dialogue, knowledge, open governance, political participation and accountability between citizens and politicians.

The mission of the project is to encourage Greek citizens to engage in politics, as well as to increase the accountability and transparency in the Greek political system.

To achieve this, the Vouliwatch team will be cooperating with politicians and civil society in order to promote a culture of dialogue and under-standing. Vouliwatch incubates and cultivates a synergistic democratic culture that inspires institutional and techno-logical innovation.

In the next pages follows a description of the main features and democracy promoting tools that Vouliwatch offers to its users:





Public questioning ("Ask your MP/ MEP"):



In a moderated platform, citizens can publicly ask questions and receive public replies by MP's and MEP's. To prevent misuse of the platform, all citizen questions and politicians' answers are cross-checked according to a published code of conduct that is aligned with the principles of open government ethics.

"Votewatch":

This application allows users to keep an eye on the voting behaviour of each MP

while informing the public on the details and background information of the legislation put forward for voting.



"Crowdsourcing legislation" ("Share ideas, experiences and make proposals"): Citizens can publicize their

experiences, ideas or proposals either at the national or at the local level. The community of users can comment and rate them. A Google map application depicts all submitted data with the option of filtering based on different criteria (location, subject categories such as e.g. education, tourism, etc.). Every month all submitted data is summarized in a

report and sent to all MPs and MEPs by our team, as food for thought and action. In case relevant parliamentary action is taken by MP's/



MEP's due to a citizen request or a public claim, Vouliwatch publishes and promotes reactions.

"Policy Monitor" ("compare party

positions"): The Policy Monitor is a digital tool which allows our users to learn about and **ENHMEPΩΣΟΥ** compare what the main political parties




positions are on given issues. It also gives them the opportunity to comment on these positions and suggest to political parties different approaches.





"The Observatory": The Observatory is Vouliwatch's parliamentary news section with daily updates on the latest developments in Parliament from the organisation's own parliamentary correspondent.

At present the Vouliwatch team is composed of three full time and three part time members as well as a volunteer.



ACTIVITIES REPORT

1. Platform Development & Digital Tools

Despite the success of Vouliwatch during its first year in operation, our team having gained more experience and feedback from both users and MPs identified a series of elements within the platform which called for improvement.

We therefore proceeded to equip Vouliwatch with all the necessary digital tools that will allow it to provide ordinary citizens, journalists and academics with accurate and timely information as well as machine-readable data on parliamentary activity.

The main objective was for Vouliwatch to establish itself as a reliable parliamentary monitoring organisation (PMO) thus developing - for the first time in Greece - digital tools and applications which will increase the oversight of citizens over the Greek legislative process.

In doing so, Vouliwatch developed a series of innovative digital applications which were incorporated in its platform and complemented the pre-existing ones. To name a few, the current Votewatch application was revamped so as to allow for the recording of anonymous voting procedures in parliament as well as including comparative tools explaining each party's position on the legislation at hand.

Existing Member of Parliament profiles on Vouliwatch's website were updated with tools allowing MPs to upload their own content and news (press releases, interviews and articles), depict their activities throughout the country via an activity map as well as upload their financial statements in a transparent and public format.

Below follows a full presentation of the new digital tools developed over the past year:





1α. Updated MP profiles

The development of the new MP profiles on Vouliwatch's platform was completed in November 2015. The purpose of the action in question was dual, firstly to provide citizens with further information on parliamentarian's activities whilst at the same time promoting financial transparency and secondly to increase the motivation of MPs to interact with the platform as the new features on their profiles allow them to better promote their work to a wider audience. As this section will indicate, despite the relatively short space of time since the launch of the aforementioned features, both goals were achieved.

Specifications of new profiles

Prior to the design of the new MP profiles, the main features one could find in them were: the CV of the Member of Parliament, the Committees that she/he is a member of, the political party he/she belongs to, their constituency and of course the question and answer application where users can submit their questions to them.


The **new features** developed for the MPs profiles include:

- Publication of MPs news and issues of general political interest
- Map projection of MPs activities
- Publication of press releases and videos from plenary so as to give journalists, researchers and citizens the possibility to be updated on information at a local and a national level
- publication of their personal financial reports and reviews
- Listing of the latest parliamentary votes they participated in
- Question and Answer counter



Με επιστολή του το Σωματείο Διαλογής και Ψύξης Νάουσας, προς το Υπουργείο Εργασίας Κοινωνικής Ασφάλισης& Κοινωνικής Αλληλεγγύης την Διοίκηση ΟΑΕΔ καθώς και την Περιφερειακή Δ/νση ΟΑΕΔ Κεντρικής Μακεδονίας επισημαίνει:

«Στις επιχειρήσεις διαλογής, τυποποίησης, ψύξης αγροτικών προϊόντων απασχολούνται πολλοί φτωχοί αγρότες – αγρότισσες εποχικοί με ασφάλιση ΙΚΑ για να συμπληρώσουν το πενιχρό εισόδημά τους. Σ' αυτούς ο ΟΑΕΔ καθυστερεί να εκδώσει αποφάσεις ένταξης στο Ταμείο Ανεργίας ενώ έχουν τις προϋποθέσεις γιατί έχουν εισόδημα από τα χωράφια τους πάνω από 1.467,35ευρώ, περιμένοντας νέα απόφαση από το ΔΣ του ΟΑΕΔ. Η απαράδεκτη αυτή εξέλιξη στοχεύει στην παραπέρα μείωση των δαπανών για τους άνεργους. Πρέπει να λυθεί ΤΩΡΑ. Σ' αυτές επίσης τις επιχειρήσεις που η εργασία είναι εποχική, οι περισσότεροι εργαζόμενοι κυρίως γυναίκες δεν μπορούν να δημιουργήσουν προϋποθέσεις ένταξης στο Ταμείο Ανεργίας (125 ημερομίσθια αφαιρούμενων των 2 τελευταίων εργάσιμων μηνών). Πολλοί δεν μπορούν να δημιουργήσουν προϋποθέσεις θεώρησης βιβλιαρίων υγείας, (τουλάχιστον 50 ημερομίσθια) ενώ η απλήρωτη – ανασφάλιστη εργασία και η εντατικοποίηση έχει ξεπεράσει κάθε προηγούμενο Αρκετές επιχειρήσεις αξιοποιούν τον v.3518/2006 και την εγκύκλιο του ΙΚΑ 42/26-5-08 που επιτρέπει στους βιομήχανους την πιο άγρια εκμετάλλευση των εργαζομένων, προσλαμβάνουν εποχικό προσωπικό που είναι στον ΟΓΑ και όχι στο ΙΚΑ (ενώ πρόκειται για εξαρτημένη εργασία) και απαλλάσσονται από εργοδοτικές εισφορές.»

Το σωματείο διεκδικεί: Άμεσα με απόφαση ΔΣ του ΟΑΕΔ να δοθεί το Ταμείο Ανεργίας στου εργαζόμενους – φτωχούς αγρότες. Να καταργηθεί ο v.3518/06 και η εγκύκλιος 42/26-5-08. Να ενταχθούν όλοι οι εποχικοί εργαζόμενοι στον ν.1836/89. Να εντάσσονται στο Ταμείο Ανεργίας με 80 ημερομίσθια χωρίς να αφαιρούνται οι δύο τελευταίοι μήνες. Να θεωρηθούν τα βιβλιάρια υγείας. Να δοθεί έκτακτο επίδομα 1500 Ευρώ σ' όσους δεν έχουν προϋποθέσεις ένταξης στο Ταμείο Ανεργίας. Να παρθούν μέτρα προστασίας των ανέργων, να μην κοπεί ρεύμα – νερό – τηλέφωνο, να μην βγει στο σφυρί σπίτι άνεργου.












View of an uploaded press release










View of interactive map showcasing the MP's activities

Impact of Action

The launch of the updated MP profiles resulted, as expected, in the overall increased interaction of MPs with the platform. This in practical terms means that a considerable number of MPs, including many that hadn't previously shown an interest in Vouliwatch, started uploading content on their profiles on a daily basis while the number of answers to question by citizens increased significantly.

Namely, since the launch of the new profiles on the 23rd of November 2015, Vouliwatch has received a total of **389 entries** by MPs which include press releases, articles, interviews and videos. Finally during this four month period a **total of 31 MPs** engaged with the platform for the first time (either by answering questions or uploading content).

This in itself is a great achievement for Vouliwatch as one of the short term goals of the organisation is for Members of Parliament to include the interaction with Vouliwatch's platform (and therefore with citizens) in their daily work routine. Moreover by browsing an MPs profile on Vouliwatch citizens can now have a complete view of their activities.

On the other hand the financial transparency tool that was developed in order to allow MPs to upload their financial details, so far hasn't been as popular in fact only one entry has been uploaded to this day.

This came to no surprise as MPs financial transparency is an issue often kept in the dark at institutional level too. Despite this Vouliwatch is confident that in time more and more MPs will gradually start uploading their financial details hence causing a domino effect.

Vouliwatch has been in touch with a number of MPs who are in favour of disclosing their financial details and is hopeful that within the coming months more of them will do so.





1b. Development of new Votewatch tool

Prior to the launch of the new Votewatch application Vouliwatch was only able to record parliamentary roll call votes, thus leaving out a considerable number of legislations passed through parliament.

Since the launch of this application in early December 2015 this has changed and Vouliwatch can now present to its audience a complete picture of parliamentary legislative activity, thus enhancing even further its role as a parliamentary monitoring organisation.


Specifications of Votewatch

Vouliwatch is now able to present in a comprehensible manner the voting procedures and results for all bills passed through Parliament.

The tool in question contains **short summaries of the political parties' positions** on each piece of legislation therefore giving the opportunity to citizens to **compare their voting behaviour vis a vis their original party positions** on the given issue.

It provides all relevant details of the bill in question (i.e. type of bill, parliamentary committee involved and names of rapporteurs) as well as summarizing its contents. Moreover a **comprehensive archive** was developed which allows citizens to search and browse through different bills.


Finally, a **poll** was included in the application through which Vouliwatch's users can indicate their own voting preference.

Τέλος, τονίζει την ανάγκη να υπάρξει στη χώρα μας γαιοπολιτική στροφή προς τη Ρωσία.

Επίσης, κάνει λόγο για τη μη αναφορά οικονομοτεχνικών στοιχείων από την πλευρά του γενικού λογιστηρίου του κράτους με αποτέλεσμα να μην αναφέρονται οφέλη για την ελληνική οικονομία.

Συνοψίζοντας, χαρακτηρίζει σημαντικό οδικό άξονα τη Λευκορωσία καθώς διέρχονται -μέσω αυτής- στη Ρωσία ελληνικά προϊόντα.

1c. Vouliwatch Data

A new 3 part section was developed on the website which gathers and presents all the data produced by the platform through the interaction of both MPs and users. The purpose of this is to present trends in terms of questions being asked as well as to monitor the engagement of MPs and parties.

In particular as the screenshots below demonstrate **Vouliwatch Data** records the questions asked by citizens as well as their crowdsourced ideas by clustering them into specific thematic categories.

Moreover by clicking on the relevant thematic category one can have access to all the questions that have been asked on the given issue (same principle applies for the crowdsourced ideas and proposals).










Another feature of Vouliwatch Data is the top and under five table which lists the most and least active MPs in terms of the number of questions that they have replied to.







Finally, Vouliwatch Data features a table measuring the response rate of parties.








1d. Revamped Policy Monitor

The Policy Monitor - which with minor alterations is now a permanent feature of the platform — is a digital tool that allows users to inform themselves, compare and contrast political party positions on a series of topical issues (i.e. education, unemployment).

In preparation for the national elections of September 2015 the Vouliwatch team reworked and updated the content of the tool in question by recording, summarising and introducing the updated positions of the political parties. In addition to this, the outlook of the tool in question was considerably improved.

1e. Extra features


In addition to the above mentioned digital tools, over the past year Vouliwatch introduced a series of new features. Namely, every weekend Vouliwatch compiles in a comprehensive report the most important parliamentary news and activities of the past week covering both the Greek Parliament as well as the European one (with a special focus on the activities of Greek MEPs). Both reports are then widely and freely disseminated to the platform's users as well as to media partners such as Huffington Post Greece.

Additionally, Vouliwatch recently launched a series of **interviews with Greek MEPs** in an effort to familiarise its users with the work and activities of their elected representatives in Brussels.





Finally, a **new section** was developed on the website where users can navigate through all citizen's questions, MP's answers, crowdsourced ideas as well as the content uploaded by MPs.







2. Advocacy Work – Open Government & Freedom of Information

Access to information, open data and good governance constitute undoubtedly essential elements for a transparent and inclusive democracy. Over the course of Vouliwatch's second year, the organisation has worked intensively towards gaining the required expertise and knowledge so as to effectively spear head the campaign for more openness and transparency in Greece.

To this end, the Vouliwatch team has worked towards expanding its national and international network of partners active in the field in question, participated in important international meetings and forums and embarked in relevant transnational projects.

In particular, Vouliwatch has been active in promoting the **Open Government Partnership (OGP) agenda in Greece** focusing especially on the implementation of the country's **2014-2016 Action Plan** and parliamentary openness. Over the past year the organisation's team has carried forward a series of advocacy actions so as to push this agenda further. Representatives of Vouliwatch met with the Minister of Interior who in turn committed himself to advancing the OGP Action Plan commitments, while a series of letters were sent to all political parties and MPs outlining the importance of establishing a culture of openness and good governance in Greece.

In addition as a member of the Open Government Partnership, Vouliwatch attended in October 2015 the **OGP's Global Summit in Mexico City** which provided an excellent opportunity to exchange ideas, best practices and establish partnerships with NGOs from around the world.

Moreover, in the next couple of months, following the organisation's proved commitment to openness and good governance, Vouliwatch will take an active role in the consultation process for the drafting of the new **OGP Action Plan for Greece 2016-2018.**





Finally, Vouliwatch provided its endorsement to the **Periphery of Central Greece** in its bid to participate in the OGP Subnational Unit Pilot Progrm designed to advance open government reform at regional level.

The **right to access to information** in Greece is yet another cause that Vouliwatch has been advocating for over the past year. Following the establishment of partnerships with leading European NGOs such as **Access Info Europe**, Vouliwatch has embarked in a project whose long term objective is to contribute to improvements in government transparency and accountability in accordance to international standards, as well as build capacity and skills for civil society organisations to exercise the right of access to information.

In practice Vouliwatch has updated the **Right to Information Rating for Greece** while also carrying forward a <u>legal analysis of transparency of decision making</u> in Greece.

Furthermore Vouliwatch sent its first freedom of information request to the Greek Parliament asking for the release of minutes of meetings of specific parliamentary committees as well as data pertaining to the parliamentary activity of MPs.







3. Disseminating the Parliamentwatch model

Part of Vouliwatch's mission is the dissemination of the Parliament Watch model in countries where parliamentary monitoring organisations or civic engagement initiatives are not present.

Having this in mind, Vouliwatch embarked on an EU funded project (Erasmus+) along with partners from Cyprus (MakeWaves), Greece (Crowd Policy) and France (Café Babel) in order to set up a parliament watch organisation in Cyprus. The scope of this project is to empower young people in Cyprus by creating more opportunities for their participation and greater transparency and accountability in politics. The project which officially started in November 2015 is expected to be concluded with the launch of the **Parliament Watch Cyprus platform** in November 2017.

4. Events & Workshops

During this second year Vouliwatch organised a series of events including promotional presentations, political labs, open discussions and workshops.

4.1 Vouliwatch Presentation to Members of Parliament

On the **25th of June 2015**, our team hosted an exclusive presentation of Vouliwatch to the recently elected Members of Parliament and their assistants in an effort to acquaint them with the platform and its functions as well as with the overall goals and aspirations of the organisation. The event presented an excellent opportunity for both parties to establish a first contact, exchange ideas on how to improve the platform as well as build trust.







4.2 Vouliwatch's 3rd open political discussion

Having in mind that Vouliwatch needs both a strong online as well as an offline presence, our team introduced in the organisation's broader set of activities the hosting of live participatory discussions and debates between citizens, experts and politicians.

On the **13th of January 2016** Vouliwatch, in partnership with the media outlet ThePressproject, hosted its **third political debate which focused on the TTIP** (**Transatlantic Trade and Investment Partnership**). The event was a great success as it attracted more than 180 participants, while the speakers panel featured the Minister of Economy, MPs from SYRIZA, New Democracy and Potami, stakeholders from the business world as well as activists and academics.

It is worth mentioning that this was the **first public discussion in Greece on the TTIP** where both sides of the argument were presented by politicians and experts from different fields of expertise. Moreover the event received wide press coverage both by local and international media.

4.3 Conference "Tools for Democracy"

On the 15th of January 2016, Vouliwatch along with the Laboratory of Education Policy, Research, Development and Interuniversity Cooperation of the University of Piraeus and the Ministry's of Education Department of Educational Radio-Televsion organised a conference at the University of Piraeus titled "Tools for Democracy". The conference was designed to present teachers, academics and post graduate students innovative tools and methods for citizen engagement in the democratic process as well as to encourage teachers to include such tools in their teaching programs. The confenrence provided an excellent opportunity to introduce Vouliwatch to the academic community and underline its potential as a learning tool for students.







4.4 Vouliwatch NGO Workshop "United We Ask 2.0"

On the **15th of March 2016**, Vouliwatch implemented for the second consecutive year an ambitious yet innovative concept which aimed both at fostering a culture of cooperation between Greek civil society organisations as well as introducing Vouliwatch as a reliable ally in their efforts to advance their agendas in Parliament.







A workshop titled "United We Ask 2.0" was organised where representatives from 25 NGOs were divided into working groups according to their field of action.

They were then asked to discuss and jointly agree on specific common issues that they wished to bring to the attention of Members of Parliament.

Once these were determined each group would collectively send their proposals/ questions to Members of Parliament through Vouliwatch's platform. The working groups in question were the following:Open and Good Governance, Equality & Social Exclusion, LGBTQ Rights, Refugee Crisis, Solidarity, Environment.







5. Media outreach

The public's **heightened interest in politics** combined with the innovative character of Vouliwatch resulted in our project enjoying a considerable degree of media attention for a second consecutive year.

Over the last year our team has given interviews on local and international media, printed and digital press as well as TV and radio. Namely Vouliwatch was featured 5 times on TV, 4 times on radio and 8 times in the press. Below follows a complete list of all media appearances including the relevant links.


OUR IMPACT IN NUMBERS

This part of the report attempts to quantify and measure the impact of Vouliwatch's activities during the second year of its operation. All metrics and analytics presented here refer to a twelve month period (16/03/2015 – 16/03/2016).

Users & MP Engagement

In the second year of Vouliwatch's operation a significant rise in the answer rate as well as the overall engagement of MPs was recorded. In particular, compared to the first year of the platform's operation where a total of **74 answers** were received, during the second year **129 answers** were provided by MPs.

Moreover since the launch of the new profiles on the 23rd of November 2015, Vouliwatch has received a total of **385 entries by MPs** which include press releases, videos of their speeches in parliament as well as interviews and articles in the press. Overall in the course of this second year a total of **49 new MPs engaged** with the platform for the first time. The above numbers suggest that for a considerable number of MPs the interaction and engagement with Vouliwatch has become part of their daily work.

Users Engagement

As for the engagement of users with the platform, in the course of the 2nd year a total of **404 questions** were posted on MP's profiles while Vouliwatch hosted **55 crowdsourced ideas and proposals**. Additionally **533 users registered** on the platform bringing the total number to **1615**. Finally, in terms of Vouliwatch's social media impact, its **Facebook** page received **2,357 new likes** while its **Twitter** account attracted **1,909 new followers**. Currently the Facebook page numbers **10,667 likes** while the Twitter account has **4,416 followers**.










Platform's Analytics

The popularity of Vouliwatch over the course of its second year of operation increased significantly, it received in fact a total of 308,995 unique visitors, 408,408 sessions and 687,881 page views.



Compared to the first year, as the table below suggests, the number of unique visitors rouse by **208,621** while the page views and sessions increased by **130,13%** and **200.02%** respectively.







FINANCIAL OVERVIEW

Vouliwatch is a non for profit organization and as such its main sources of funding derive from private donations, participation in projects and grants. Since the start of our endeavor Vouliwatch's team has put in a great deal of pro-bono work and with the invaluable help and support of our network of volunteers managed to keep the organization running.

As with most non for profits funding is and will be a challenge, however with its continuous rise in popularity, its professionalism and proved track record of efficiency we are confident that more donors, foundations and funded projects will provide enough resources for the project to grow even further.

It is important to note at this point that it is crucial for our organization to maintain its non-partisan character, therefore our team is committed to not receiving donations and grants from political parties, government agencies and organizations /foundations directly linked to political parties both within and outside Greece.

This section of the report will provide a financial overview of Vouliwatch over the past twelve months, specifically it will present our revenue, sources of funding and expenses by category.

a. Sources of funding / Revenue


Individual donations as well as the participation of Vouliwatch in funded projects were for yet another year the main sources of revenue for the organisation.

Vouliwatch Sources of funding


